- E. Harvey explained that the money budgeted for the year has not been set, the club is still working from last year's information.
- F. Harvey brought the following to the club's attention: The **2.3% Medical Excise Tax** that began on January 1<sup>st</sup>, 2013 is supposed to be "**hidden**" from the consumer, but it has been brought to the Public's attention by hunting and fishing store Cabela's who have refused to hide it and are showing it as a separate line item tax on their receipts. Other stores, such as Bass Pro Shops may follow Cabela's lead. The question is: Can you use this tax on your income tax forms for credit?

- 10. Final notes: Fred Beard was concerned about the lack of fish stockings at area lakes. Randi Wayland passed on information that she has Privy to: Two state hatcheries are dry. Harvey also did some research on the topic, and found out that the biologists don't need to restock fluctuating lakes like Choke Canyon, Amistad and Falcon. Monies that used to go to TPWD now go into the general fund (thanks Gov. Perry), and would not re-allocate the money to TPWD.
